

COOKIES POLICY

This policy is effective as of September 25th, 2023. Please note that this policy may be updated from time to time.

We use cookies to ensure that the TokenScope website (<https://tokenscope.com/>, hereinafter referred to as “this Website”) works properly, to personalize advertisements and other content, to provide social media features, and to analyze web traffic. We also share information about your actions on this Website with our social media, advertising and analytics partners.

How TokenScope Use Cookies and Other Similar Technology on this Website?

We can place cookies and other similar technology on your device, including mobile device. The following information may be collected through cookies or similar technology: your device unique identifier, your device IP address and information about your device’s operating system, mobile carrier and your location information (to the extent permissible under applicable law). Every time you visit this Website, you will be prompted to accept or reject cookies.

What are Cookies?

Cookies are small text files that are placed into your device when you visit a website and allow the website to recognize it. Cookies store information about your visit to the website, which may include the content viewed, language preference, time and duration of each visit, and advertisement accessed. Cookies managed by this Website only are called “first party cookies” whereas cookies from third parties are called “third party cookies”.

Why Do We Use Cookies and Similar Technologies?

Cookies are a useful mechanism that do many different jobs, such as letting you navigate between pages efficiently, remembering your preferences and generally improving the user experience. They can help to ensure that the advertisements you see online are more relevant to you and your interests and enable us to identify your preferences. There are different set of cookies, and we will specify them later.

Does TokenScope Use Cookies for Marketing and Analytics?

Yes, we may use information collected from our cookies to identify user behavior and to serve content and offers based on your profile, and for the other purposes described below, to the extent legally permissible in certain jurisdictions. In other cases, we can associate cookie information (including information from cookies placed via our advertisements on third party websites) with an identifiable individual.

Does TokenScope Use Any Cookies from Third Party Companies?

Some cookies, web beacons and other tracking and storage technologies that we use are from third party companies (third party cookies) to provide us with web analytics and intelligence about this Website, which may also be used to provide measurement services and target ads.

What if I Don't Want Cookies or Similar Tracking Technologies?

If you do not want cookies being placed on your device, you can ignore the cookies banner on the main page of this Website. If you want to remove existing cookies from your device, you can do this using your browser options. However, please note that deleting and blocking cookies may affect your user experience as you may not be able to use the full functionality of this Website.

What Types of Cookies Does this Website Use?

The cookies used on this Website have been categorized below. However, it is important to note that not all cookies may be used in all jurisdictions or websites. A list of the categories of cookies used on this Website is set out below:

- **Strictly necessary cookies** are necessary for this Website to function and cannot be switched off in our systems. They are usually only set in response to actions made by which amount to a request for services, such as setting your privacy preferences, logging in or filling in forms. You can set your browser to block or alert you about these cookies, but some parts of this Website will not then work. These cookies do not store any personally identifiable information.
- **Performance cookies** allow us to count visits and traffic sources so we can measure and improve the performance of this Website. They help us to know which pages are the most and least popular and see how visitors move around this Website. All information these cookies collect is aggregated and therefore anonymous. Without these cookies, we will not know when you have visited this Website and will not be able to monitor its performance.
- **Functionality cookies** enable this Website to provide enhanced functionality and personalization. They may be set by us or by a third-party provider whose services we have added to our pages. Without these cookies, some services may not function properly.
- **Targeting cookies** may be set through this Website by our advertising partners. They can be used by these third parties to build a profile of your interests based on the browsing information they collect from you, which includes uniquely identifying your

browser and terminal equipment. Without these cookies, you will still see basic advertising on your browser that is generic and not based on your interests.

- **Social media cookies** are set by a range of social media services that we have added to this Website to enable you to share our content with your friends and networks. They are capable of tracking your browser across other websites and building up a profile of your interests. This may affect the content and messages you see on other websites you visit. Without these cookies, you may not be able to use or see these sharing tools.
